- Tuition is paid in full or on a monthly payment plan over a 12-month period, beginning July 2026 through FACTS Management Company. If tuition is paid in full by June 1, 2026 by cash or check, there will be a 2.5% discount.
- For families re-enrolling, the non-refundable re-enrollment fee will be charged to your FACTS account on **2/1/2026**
- For students who have been accepted and enrolled, but decide to withdraw **before** August 15, 2026, a 50% deduction will be applied to tuition refunds. If a family has paid the full tuition at this time, then the 50% deduction will only apply for two months, and the remainder will be fully refunded.
- For students who have been accepted and enrolled, but decide to withdraw **after** August 15, 2026, the July and August tuition will be forfeited. If a student is withdrawn and/or removed during the school year, the current monthly tuition is due in full. Any subsequent monthly tuition is refunded provided that all other fees or expenses have been paid. If tuition was paid in full, a refund of any subsequent tuition will be made.
- In the event of a financial crisis—such as unemployment or serious health concern—which prevents making regular tuition payments, the family must contact the Business Manager promptly at lupea@sainttheresaparish.com. Tuition payments are due according to the schedule established at the time of enrollment. Accounts that are more than **30 days past due** may result in the **student's withdrawal from the school** or satisfactory arrangements are made with the Business Manager.
- **A family seeking tuition assistance for the coming school year must complete a Tuition Assistance Application available online at <https://www.arlingtondiocese.org/catholic-schools/our-schools/tuition-assistance/> This application is due to FACTS Tuition Aid by March 14, 2026.** This information, plus a review of the family's service to the parish, and available funding, will be used to make a fair decision concerning tuition reduction.
- In-Parish Tuition is offered for families who live within the parish boundaries, are registered members of St. Theresa Parish and whose child(ren) are baptized in the Catholic Faith. Catholic families living outside the boundaries & registered with another parish, whose child(ren) are baptized in the Catholic Faith will receive the Out of Parish Rate.
- For those who move from within STC boundaries to outside of parish boundaries, in-parish tuition will be grandfathered for the current academic year only—August to June, but not for the calendar year.
- All families are required to perform 16 hours of service per year or opt out for a fee. The whole parish supports the operations of a school; tuition revenue does not cover all these costs. *Volunteer service hours must be completed to be eligible for tuition assistance.*
- If a family has outstanding fees (e.g. tuition, service hours payment, lost textbooks) they will not be eligible for automatic re-enrollment nor will the official transcripts be sent to the new school until the account is paid in full.
